FUTSAL 4 LIFE: PATRON CONDITION OF ENTRY

All Futsal 4 Life (F4L) patrons must adhere to the following F4L Patron Condition of Entry

- 1. Respect the decisions of Match Officials.
- 2. Never ridicule or scold a someone for making a mistake. Always be positive in your support for players.
- 3. Respect the rights of every person regardless of their age, gender, sexual orientation, ability, race, colour, religion, language, politics, national or ethnic origin.
- 4. Violence is prohibited against another person including fellow spectators, players or match/team officials (including coaches).
- 5. Not engage in acts of discrimination, harassment, or abuse towards any person, including: the use of obscene or offensive language and/or gestures.
- 6. Comply with all F4L Terms of Admission including provisions relating to security screening, intoxication, and items that are prohibited by law or restricted by policy from being brought into the Venue.
- 7. Respect the use of facilities and equipment provided.
- 8. Provide free view of the game to other spectators.
- 9. Never enter or attempt to enter the field of play or playing arena without permission.
- 10. Disorderly conduct that may injure the reputation and goodwill of F4L and the code of Futsal generally is prohibited. Any person who does not comply with this F4L Patron Code of Conduct or is disturbing to the event, may be evicted from the venue and also banned.
- 11. No pets are allowed inside.
- 12. No bikes are allowed inside. No motorbikes to be parked outside of car parking area.
- 13. No smoking or vaping on the properties.
- 14. No consumption of alcohol on the properties unless by a licensed permitted supplier.
- 15. Children must be under the supervision of a guardian.
- 16. Security surveillance is monitored and recorded throughout all Futsal 4 Life facilities.
- 17. Photography and videography is strictly prohibited within Futsal 4 Life Facilities unless preapproved by Futsal 4 Life.

Where Futsal 4 Life reasonably suspects images are being taken the person taking the images may be asked to delete the images and may be liable to immediate removal from the facility

- 17. The use of mobile devices within change facilities is not permitted.
- 18. Appropriate' footwear and clothing must be always worn. Non-marking shoes must be always worn on court surfaces.
- 19. Must not operate or use any electronic device or audio equipment to broadcast sound or video at a volume likely to cause a nuisance to another person or to unduly interfere with the amenity of the venue
- 20. Patrons agree to comply with all health regulations and laws. For the avoidance of doubt, this includes any Directions issued under the Public Health and Wellbeing Act 2008 (Vic). Failure to comply with all health regulations and laws may result in ejection.
- 21. By spectating at our leagues and tournaments, you consent to F4L using your image and/or other materials featuring you (including testimonial quotes provided by you) for the above purposes, and acknowledge that:
- a. F4L owns all rights to the images, recordings, and testimonial quotes.
- b. You will not be entitled to any payment, unless otherwise agreed.
- c. F4L may share these materials with third parties, such as newspapers and paid social media organisations.
- d. F4L may decide not to use, publish, or reproduce any materials of you.
- e. You are entitled at any time to withdraw your consent to the above uses by contacting us and we will take reasonable steps to discontinue any further use of the image, recording and/or testimonial quote.

Emergencies & Medical Treatment

- If you suffer any injury or illness, you agree that a representative of Futsal 4 Life may provide
 or facilitate evacuation, first aid and/or medical treatment at your expense and that your
 acceptance of these conditions constitutes your consent to such evacuation, first aid and/or
 medical treatment. You agree to reimburse Futsal 4 Life for any costs or expenses incurred
 in providing such medical treatment.
- In the event of an emergency requiring evacuation, all patrons follow the instructions provided by the area warden or emergency services.
